## ENTITY OVERVIEW

Jiangsu Dingsheng New Materials Joint-Stock Co., Ltd. ('the Entity') is the parent company overseeing several subsidiaries, including Hangzhou Five Star Aluminum Co., Ltd. and Hangzhou Teemful Aluminum Co., Ltd. The Entity is headquartered at No. 392, Jingrun Avenue, Zhenjiang Jinkou Industrial Park, Zhenjiang City, Jiangsu Province, China. It specialises in the research, development, production, and sales of Aluminium sheets, strips and foils, with processes including re-melting, continuous Casting, cold rolling, coating, slitting and oxidation. Established in 2003 and listed on the A-share market in 2018, the Entity employs approximately 3,000 people and occupies an area of approximately 67 hectares.

Its subsidiaries, Hangzhou Five Star Aluminum Co., Ltd. and Hangzhou Teemful Aluminum Co., Ltd., are located at No. 1 Zicheng Road, Fengdu Industrial Park, Pingyao Town, Yuhang District, Hangzhou City, Zhejiang Province, China. Managed as a single operational team, they focus on Aluminium foil processing, producing materials for power batteries in new energy vehicles and other foil applications. Together, they currently employ approximately 1,400 people, occupy an area of 32 hectares, with an annual production capacity of approximately 160,000 tonnes.

## CRITICAL INCIDENT – JULY 2024

On 10 July 2024, a critical incident occurred at the Entity, which resulted in the fatality of a Worker. This incident occurred before this ASI Re-Certification Audit and Scope Change (16 – 30 September 2025) which identified no Material issues or findings relating to the management of Occupational Health and Safety (OH&S) on site. The Entity has demonstrated consistent performance with its OH&S systems, and no non-conformities relating to the relevant Criteria of the ASI Performance Standard have been identified in both this Audit, and prior ASI Performance Standard Audits.

Discussions were held between the ASI Secretariat and both the Lead Auditor and representatives of the Accredited Auditing Firm provided additional context during the Oversight assessment.

During the process of moving Aluminum Coil A (approximately 12 tonnes) toward the vicinity of Aluminum Coil B using an electric hoist, an employee entered the coil storage area and was struck and crushed by the swinging coil. Despite being immediately transported to the hospital, the employee succumbed to their injuries. The employee violated operating regulations by entering the Aluminium coil lifting zone. According to the Entity's Standard Operational Procedure (SOP) requirements, operators are strictly prohibited from entering the lifting zone, and personnel must not walk beneath Aluminium coils while they are being hoisted. Based on the local government's investigation report, the Entity had issued the applicable SOP and had provided relevant safety training to all employees prior to the commencement of their duties.

The actions implemented following the fatality included an adjustment of the fixed placement positions of Aluminum coils on-site to ensure sufficient operating space, with the longitudinal distance between coils being more than 1.5 times the length of the electric hoist (C-hook) and the horizontal space between coils exceeding 50 cm. In addition, the Entity has provided safety training to operators on site (over 400 people).

A joint investigation team was established by the local government regulatory authorities, including the Emergency Management Bureau, Public Security Bureau, Federation of Trade Unions, and government representatives, to conduct an on-site investigation. As stated in the final investigation report issued by the relevant government department, the root

cause identified related to the employee lacked adequate safety awareness and operated in violation of operational regulations.

Corrective actions included in the investigation findings required the Entity to:

- Fulfill its primary responsibility for work safety in accordance with the law
- Strengthen night production management and safety inspections
- Enhance safety education and training for employees to ensure that personnel have the necessary work safety knowledge, risk identification, and emergency response capabilities.
- Increase penalties for employees for violating Health and Safety regulations/legal requirements and identify behavioural violations,
- Impose strict and severe penalties.

These corrective actions have been completed and implemented, as a result, the Entity reviewed its OH&S Management System, related procedures, and the applicable SOP following the incident. The specific actions included:

1. Implemented comprehensive rectification and prevented the recurrence of similar incidents. The Entity has organised accident-specific safety training for 2,543 employees to enhance risk identification and standardised safety awareness and practices.
2. The adjustment of all designated storage locations for all Aluminium coils across the company to ensure safe operational space and spacing between coils.
3. Post-accident training for employees who violated safety regulations, including review of operating procedures, reflection on safety behaviours, watching safety awareness videos, incident retrospectives, and family impact interviews.
4. Conducted specialised training for overhead crane operation which covered theoretical knowledge, routine inspection procedures, and practical operation skills. This training is conducted on a regular basis and to date, a total of 322 employees has been trained.
5. Conducted on-site safety improvements in accordance with the law, such as strengthened production management and safety patrols; enhanced employee safety education and training and ensured that personnel have the necessary safety production knowledge and emergency response capabilities.
6. Established and implemented verification and supervision mechanisms to ensure all corrective measures are fully implemented and to prevent recurrence of similar incidents. This included strengthening daily inspections, a taskforce to verify implementation and random interviews of employees of safety protocols.

In response to this incident, the Lead Auditor has recommended a Minor Non-Conformance for Criterion 11.1a, as the corrective actions arising from the incident investigation and determined that these were appropriate and implemented effectively since the aftermath of the incident.
