The Aluminium Stewardship Initiative (ASI)

The Aluminium Stewardship Initiative (ASI) is a standards setting and certification organisation that recognises and fosters the responsible production, sourcing and stewardship of aluminium. As a member-based, global initiative, ASI is the result of producers, users and stakeholders in the aluminium value chain coming together to build consensus on 'responsible aluminium'.

ASI is developing an independent third party certification program to ensure sustainability and human rights principles are increasingly embedded in aluminium production, use and recycling. ASI's Performance Standard covers critical issues for the entire aluminium value chain including biodiversity management in mining, indigenous people's rights, greenhouse gas emissions, waste management and material stewardship.

The ASI Chain of Custody (CoC) Standard

The Chain of Custody (CoC) standard aims to link responsible production with responsible sourcing and support increased emphasis on sustainability in procurement practices. The CoC Standard aims to support responsible supply chains by:

- Providing a common standard for ASI Members who wish to implement chain of custody systems;
- Establishing requirements that can be independently audited to provide objective evidence for the granting of ASI CoC Certification; and
- Serving as a broader reference for the establishment and improvement of responsible sourcing and material stewardship initiatives in metals supply chains.

The ASI CoC Standard defines requirements for Entities and Facilities implementing chain of custody management systems, including systems for sourcing, administration and transfer of CoC Aluminium.

Other metals in aluminium alloys, platings or coatings, or other product components, and other materials such as plastics, glass, paints and agricultural products, are not covered under the ASI CoC Standard.

Standards development process

Draft 1 of the CoC Standard was developed under IUCN and an ASI Standards Setting Group (SSG) during 2014, with a <u>public consultation period</u> open from 14 July to 7 September 2014. Eight sets of comments on the draft were received and <u>published on the ASI website</u>.

Following discussion of received comments, a <u>Draft 2 of the CoC Standard</u> was then made available on the ASI website in January 2015. While the draft has been publicly available since that time, a formal comment process was not convened.

During 2015, ASI became an independent organisation and primarily focused on developing its governance and basic assurance model with members and stakeholders for more than 12 months.

In 2016, work re-commenced on Draft 3 of the CoC Standard with the new ASI Standards Committee. Given the elapsed time since Draft 2, and the adoption of a new <u>ASI Standards Setting Procedure</u>, this consultation plan covering Drafts 3 and 4 was developed for public information and comment.

The purpose of these public consultation processes is to provide stakeholders with sufficient time and opportunity to provide input on the new drafts of the standard, and for ASI to communicate publicly on how this input has been taken into account.

It is anticipated that a pilot evaluation of a Draft 5, following the 2 new rounds of public comment, will be held in July 2017, and that the CoC Standard will be finalised for adoption by the end of 2017.
