Nemak is a leading company in the automotive sector, dedicated to producing and developing innovative solutions for high-quality Aluminium components. It is considered as a strategic partner for the leading automakers.

Nemak, S.A.B. de C.V. is noted as a leading provider of innovative lightweight solutions for the global automotive industry, specialising in developing and manufacturing Aluminium components for e-mobility, structure and chassis, and combustion engine (ICE) powertrain applications. Nemak currently employs approximately 24,000 people at 38 production Facilities worldwide, with approximately 900 at the Entity.

The Nemak İzmir Döküm Sanayi A.Ş. (Nemak Turkey) (the 'Entity') plant has been in operation since 1997 and was acquired by Nemak Group in 2016. The Facility continues its operations in the Atatürk Organised Industrial Zone (IAOSB), Izmir, Türkiye.
