ENTITY OVERVIEW

Guangdong Zhongya Aluminum Co, Ltd (the 'Entity') was founded in 1993 and is located at 3 East Yalu Street, Zhaoqing High-tech Industrial Development Zone, Guangdong Province, China. It was originally named 'Zhaoqing Xinzhongya Aluminum Co, Ltd.' The factory covers an area of 537,333m², with a total project investment of 80 million US dollars and an annual output of over 200,000 tonnes.

The Entity has a complete production process, including melting and casting, extrusion, anodic oxidation colouring, electro-polishing, electrophoretic painting, fluorocarbon spraying, powder coating, thermal insulation (inserting strips, pouring), deep processing, and fine processing. The workshop is equipped with melting and casting furnaces, Aluminium bar homogenizing furnaces, more than 40 extrusion machines ranging from 500T to 5500T, long billet heating furnaces and hot shears, double traction machines, polishing machines, sandblasting machines and other new equipment.

The products cover architectural decoration Aluminium materials, curtain wall Aluminium materials, industrial Aluminium materials, and special Aluminium profiles with thin walls, wide and flat sections, and super-large cross-sections. It has a new product development centre, a mold manufacturing centre and a testing centre.
