ENTITY OVERVIEW

Tri-Arrows Aluminum Inc. (the 'Entity') operates as the corporate sales office for can sheet produced at Logan Aluminum in Russellville, Kentucky. The Entity supplies rolled Aluminium sheet to the North American market, with a focus on the beverage can sheet sector.

Established in 2011, Tthe Entity provides corporate functions related to the procurement of metallic inputs and sales activities supporting the Logan Aluminum operations. The Entity currently employs approximately 80 people, including 36 women, and operates from a leased office building in Louisville. No Aluminium production or processing activities occur on site.

The Entity is owned by a consortium composed of the UACJ Corporation and Sumitomo Corporation.
